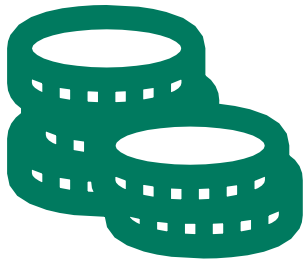

Net4SocietyHE


- **Net4SocietyHE** is the transnational **network for Cluster 2 "Culture, Creativity and Inclusive Society" National Contact Points (NCPs)** in Horizon Europe.
- We build on experience from 2008 until today and are constantly developing our **services and tools** created **to help NCPs** as well as **applicants to succeed** in their work.
- We are currently in the 6th round of EU funding/ the **6th Net4Society project**
- The current project has **21 project partners and 2 associated partners**

Net4SocietyHE project vs. Net4Society network

Net4SocietyHE: The EU-project which consists of 23 project partners and associated partners who work together to facilitate the exchange between the network members (project beneficiaries working for all Cluster 2 NCPs)

versus

Net4Society: The network of National Contact Points for Cluster 2 in Horizon Europe (all Cluster 2 NCPs)



Net4SocietyHE in a nutshell

Net4SocietyHE runs from **1. February 2022 to 31. January 2029** (7 years; into FP10)

Net4SocietyHE provides tools and services for:

- Cluster 2 **NCPs**
- Cluster 2 **applicants**
- **SSH research** communities (beyond Cluster 2/SSH Integration)
- **New stakeholder communities**, e.g. GLAM, Cultural and Creative industries
- Special support for applicants from countries with a lower success rate in H2020 (enhancing widening participation)

Net4Society services for Cluster 2 NCPs

- Most tools and services, as well as meeting opportunities offered by Net4SocietyHE are **specifically designed for Cluster 2 NCPs**
- One specific services is also designed for the use of NCPs from other Clusters, in order to support a **more successful integration of Social Sciences and Humanities (SSH) research into the other areas of Horizon Europe: becoming an SSH Ambassador**

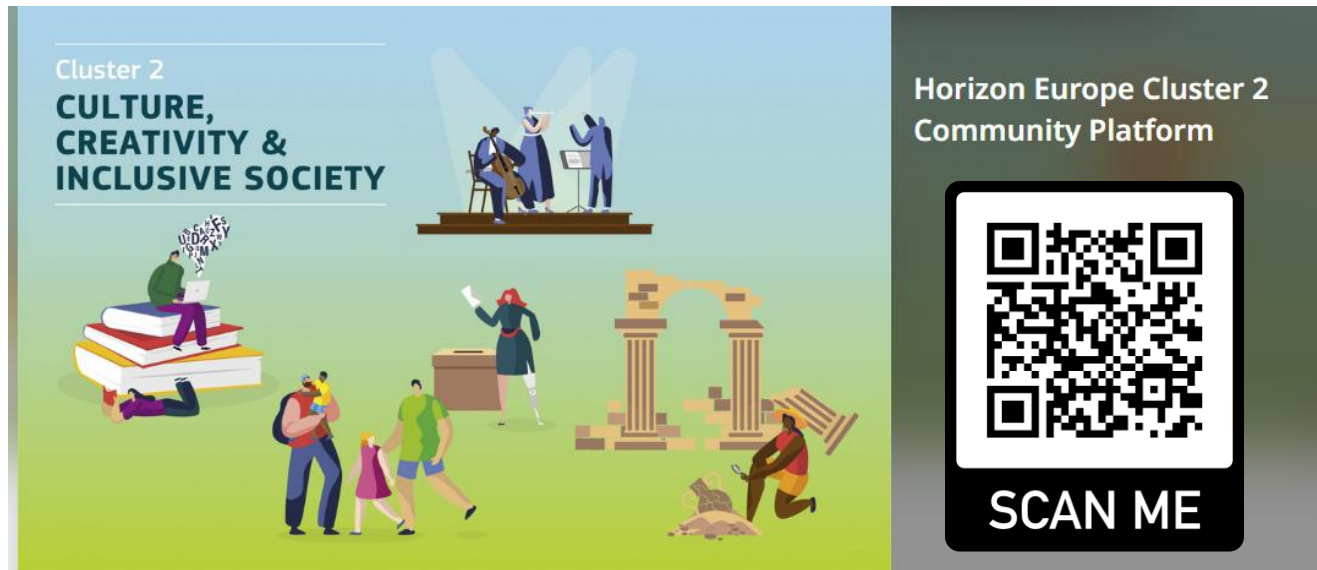

The Role of Third Countries Cluster 2 NCPs

A Case Study of Brazil

Fundação Getulio Vargas (FGV)

A private, non-profit foundation dedicated to education, research, and innovation, with a focus on applied social sciences and humanities.

Mission: to foster Brazil's social and economic development.

Successful initiatives to highlight in Cooperation in Science, Technology, and Innovation – EU - Brazil

- The **Scientific and Technological Cooperation Agreement between the EU and Brazil (2007)** is the main framework for scientific collaboration.
- **Implementation Arrangement (2016)**, signed by the EC and the National Council of State Funding Agencies (CONFAP) to allow Brazilian researchers to join European Research Council (ERC) teams.
- **Administrative Arrangement (2018, 2021)**, signed by the EC Directorate-General for Research and Innovation, the National Council for Scientific and Technological Development (CNPq), the Funding Authority for Studies and Projects (FINEP), and CONFAP to support Brazilian participation in EU Research and Innovation programs.

Horizon Europe – Brazil in Numbers

- **Brazil is the 7th country** in terms of participation in the program;
- The main participation of Brazil is in the **Marie Skłodowska-Curie Action program, with 67 approved projects**;
- The country also actively participates in the calls of **pillar 2 (global challenges)**, with approved projects in various areas, highlighting the **climate, energy and mobility cluster (14)**, and **health (8)**.
- **European Research Council – ERC**
 - **Horizon 2020: 9**
 - *Starting: 6*
 - *Consolidator: 2*
 - *Advanced: 1*
 - **Horizon Europe: 12**
 - *Starting: 8*
 - *Consolidator: 4*
 - *Advanced: n/a*

Approach: Cluster 2 NCP

Always emphasize the importance of applying the concept of SSH integration to address societal challenges more effectively, aiming to achieve more comprehensive and sustainable solutions.

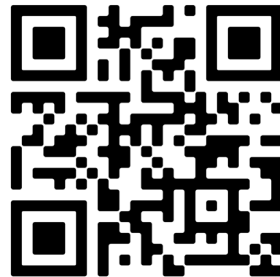
